YMOW CLIENTS ACCESS TO TWO MEALS A DAY ON MONDAY THROUGH SATURDAY AND ONE MEAL ON SUNDAY. EACH DAY'S DELIVERY INCLUDES A HOT MEAL FOR LUNCH AND A CHILLED MEAL FOR LATER IN THE DAY. IN ADDITION TO TRADITIONAL MEALS, YMOW PROVIDES FROZEN MEALS AND EMERGENCY SHELF STABLE MEALS FOR TIMES WHEN WEATHER OR OTHER CIRCUMSTANCES PREVENT DELIVERY. YMOW'S CLIENTS ARE TYPICALLY OLDER ADULTS WITH MULTIPLE CHRONIC HEALTH CONDITIONS AND VERY LIMITED INCOMES.
